The constitution, rules and regulations that govern The Militia and its members are known as **The Militia Articles**. Weapons Competencies and Uniform Expectations

No member of The Militia will be allowed to carry any weapon beyond a training setting without the required competencies being passed and documented. For information and to arrange training in these areas, please contact the Master-At-Arms. With regard to Musket and Pistol use, all current legal requirements must be complied with at all times. No member will be allowed to perform in front of the public unless they are attired in the correct clothes and equipment according to the relevant style guide for the period in question.

Under 16 Year Olds

Any member under the age of 16 years on the 01st march for the year covered by this form will not be charged any fees by The Militia. However, their participation may be of a limited nature due to safety requirements. It is also a requirement of The Militia that any under 16 year old MUST be accompanied by a parent/guardian at any event attended. Sole responsibility for the under 16 year old rests with the parent/guardian at all times.

Membership Fees
