Dear Mr. Brown,

Further to your email enquiring about European Firearms Passes.

- Muskets are treated in the same way with European Firearms Pass as they are with your certificate, therefore any muskets shown on your shotgun certificate will need to be added to the EFP if you are planning to take it to Germany.
- You can transport the muskets together to Germany in a van, however the person responsible for transporting them will need each Musket he will be taking signed onto table 2 of his certificate as shared, he will then need to advise the Firearms Licensing Unit and apply for an EFP. We will add all the muskets to his record as shared and issue an EFP with them all on. On his return to the UK he can then advise us when he no longer has access to the muskets and we will remove them from his record.
- it does not matter if the muskets are all from different force areas so long as they are signed on to the certificate of the person who is transporting them and that they inform, and have the EFP issued by their force.

Hello

I've read the info on the website about the European Firearms Pass and it all makes sense - but I have a couple of queries it doesn't cover. Would it be possible for someone to have a look at them for me? Thanks

- I am a member of a historical re-enactment unit. We are planning to visit Leipzig in Germany in October for a major commemorative event. We need to take muskets with us. In all other Firearms licensing requirements our muskets are treated as shotguns (smoothbore, single shot, over a certain barrel length) presumably EFP is no different?
- I am arranging the logistics of getting 10 or 20 chaps and their muskets to the event. One option appears to be sending the muskets over sea/ground in a van and the owners go separately by air. As I understand it this could be done as long as the person accompanying the muskets on the ground has the required certificates and has all of the muskets on their EFP. Does that sound correct?
- if the above is correct is it still possible if the owners of the guns are from a range of different constabulary areas?
- anything else you think I should know or do!
